**THE 2010 REAL ESTATE AND PERSONAL PROPERTY TAXES**  
**ARE NOW DUE AND PAYABLE**

**REAL ESTATE TAXES:**

1. Make check payable to the Town of Prairie Lake. Send to Patricia Brewer, Treasurer, 1821 8<sup>th</sup> Ave., Chetek, WI 54728.
2. First payment is due by **January 31, 2010**
3. Second payment is due **July 31, 2010**. Pay to the **Barron County Treasurer, Rm 2412, 330 E La Salle Ave., Barron, WI. 54812.**
4. All General Real Estate Taxes of \$99.99 or less on any one parcel is due in full by January 31, 2010.

**PERSONAL PROPERTY TAXES:**

1. Pay to the Town of Prairie Lake on a **SEPARATE CHECK**.
2. Personal Property Taxes are due in full by **JANUARY 31, 2010**.

**GENERAL TAX INFORMATION:**

1. All delinquent taxes are subject to an interest charge.
2. **Mailed-in payments only.** Receipts will be sent.
3. Do not pay by cash. **MONEY ORDERS OR CHECKS ONLY.**
4. Send **PAYMENT STUB** from your tax statement with your payment.
5. \$30.00 will be charged on any returned insufficient fund checks.

**CEMETERIES:**

Cost of 1 burial plot is \$100.00 at the Otterholt or the Pleasant Plain Cemeteries. Contact the town Treasurer for more information. 1-715-458-0744.

**SNOW PLOWING:**

Plowing will begin after 2 inches of snow has fallen and a total of 4 inches is expected. Plowing will be done during normal working hours (7:00 a.m. until dark). Between the hours of 7:00 p.m. and 6:00 a.m. plowing will be done on an emergency basis only when requested by a sheriff's department, fire department, ambulance department, or other such organization. The objective of snow plowing is to make township roads passable. By State Statute (81.15) the township has three weeks in which to meet this objective. Residents should not expect that all roads will be completely clear of ice and compacted snow. Driveways will not be plowed until the roads are in passable condition. Driveways are plowed by contract only; sign up is in October only, - contract is on the web.

### **BURNING PERMITS:**

Controlled Burning permits are **REQUIRED** call Al Morley 924-3155, Almar Larson 924-1815 or Janice Rustong 924-2837 to get your permit, then you are **REQUIRED** to call the Barron Co. Sheriff's non emergency number **537-3106** on the day of your burn to report the time and location of the burn. This will also apply to winter control burns when no permits need to be issued. Failure to do this can result in great expense to you. See our website for more information. Yearly burning permits are available, call for information.

**VOTER REGISTRATION:** Voter registration is now required before elections or on the day of elections-- visit website, <http://gab.wi.gov/> or call Karn Moe (town Clerk) at 924-2580 for information.

**JUNK CARS:** Barron Co. and the Town of Prairie Lake have an ordinance against junk cars on property—see website for information.

## **DOG OWNERS NOTICE**

### **ALL DOG(S) NEED TO BE LICENSED NOW**

**ALL DOGS IN THE TOWN OF PRAIRIE LAKE MUST BE LICENSED AND  
VACCINATED FOR RABIES.**

Wisconsin statutes require dogs 5 months or older to be licensed and vaccinated by a veterinarian against rabies. Dogs are to be licensed beginning **January 1, 2010**.

**CURRENT VACCINATION CERTIFICATES MUST BE SENT  
WITH PAYMENT EACH YEAR.**

The Town of Prairie Lake Dog Ordinance does not allow any dog to run at large or to be untagged. Any owner who violates any provision of this ordinance shall forfeit not less than fifty (\$50) nor more than one hundred (\$100) dollars **plus costs** for the first violation. The penalty for subsequent violations shall be a forfeiture of not less than one hundred (\$100) nor more than two hundred (\$200) dollars **plus costs**. Each violation and/or each day that a violation continues or occurs may constitute a separate offense.

### **LICENSE INSTRUCTIONS:**

1. LICENSE FEES ARE: **\$10** for each unsprayed or unneutered dog listed or **\$5** for each spayed or neutered dog. Make check payable to **Town of Prairie Lake**. (The fees have changed this year.)
2. After **April 1, 2010** a **\$5.00** late fee will be charged for each dog.
3. Pay your dog fees with a **SEPARATE CHECK. SEND YOUR  
CURRENT VACCINATION CERTIFICATE.** It will be returned. **Do not** send a vet clinic receipt; I must have the vaccination certificate.
4. To report a **animal issue** such as a lost dog, stray dogs or cats (any animal) call the Barron Co animal control enforcement officer **Mark Olson** at **537-3106** or **you may take the animal to the Humane Society in Barron.**
