

ORDINANCE 2014 - 1
ORDINANCE FOR ADOPTION OF RESTRICTED PARKING AREAS IN THE
TOWN OF PRAIRIE LAKE, BARRON COUNTY
STATE OF WISCONSIN

SECTION I – TITLE AND PURPOSE

The title of this ordinance is the Town of Prairie Lake Restricted Parking Ordinance. The purpose of this ordinance is to authorize the Town Board of the Town of Prairie Lake to regulate the stopping, standing, or parking of vehicles in the Town of Prairie Lake.

SECTION II – AUTHORITY

The Town Board of the Town of Prairie Lake, Barron County, Wisconsin, has the specific authority under §349.13, Wis. stats., to adopt this restricted parking ordinance.

SECTION III – ADOPTION OF ORDINANCE

This ordinance, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, provides for the regulation of the stopping, standing, or parking of vehicles on town highways in the town.

SECTION IV- POLICY AND PROCESS

A. The stopping, standing, or parking of vehicles on the following town highways in the Town of Prairie Lake is subject to the following restrictions and limitations:

1. 23 ½ Street in the area of Sunrise Resort- due to pedestrian crossing and a curve, there is no parking on the west side of 23 ½ Street from 9 ¾ Avenue south to 150 feet south of the southern Sunrise Resort annex entrance. (See attachment 1)
2. 23 15/16 Street on Cartwright Point: due to narrow road and poor visibility there is no parking on both sides of 23 15/16 Street from 24th street to the residence located at 887A 23 15/16 Street.(See attachment 2)
3. 23 ¾ Street- For the purpose of traffic visibility, there is no parking on the north side of 23 ¾ Street beginning at County Hwy SS traveling east and following the same side when 23 ¾ Street turns north and ends at 8 ¾ Avenue. (See Attachment 3)
4. 11 ½ Avenue Lakewood area including boat landing: There is no parking in the Lakewood area as follows: (See Attachment 4)
 - a. No parking on both sides of 11 ½ Avenue between 22 7/16 Street and 22 ½ Street.
 - b. No parking on east side of 22 ½ Street in the boat launch area.
 - c. No parking on both sides of 11 ½ Avenue from the intersection of 11 ½ Avenue and 22 ½ Street to the dead end.
 - d. No overnight parking at 2257 11 ½ Avenue (town commons water access).
5. 21 ¾ Street-22nd Street: Due to narrow roadway, there is no parking on both sides of 21 ¾-22nd Street between 11 ½ Avenue and 12th Avenue. (See Attachment 5)

B. The town chairperson, or designee, shall place appropriate traffic signs on the above-described highways on or before the effective date of this ordinance.

C. No persons may operate any vehicle on the above-noted town highways in violation of the above-noted stopping, standing, or parking restrictions and limitations. A violation shall be subject to citation and possible forfeiture as listed in the Schedule of Penalties, Fees, Deposits, and Enforcement.

D. The Town Board may establish temporary restricted stopping, standing, or parking of vehicles areas upon passage of a town resolution. Such temporary measures may not exceed 5 days in duration.

This ordinance is effective on December 10, 2014.

The town clerk shall properly post or publish this ordinance as required under §60.80, Wis. stats.

This ordinance was adopted at a regular meeting of the Town Board of the Town of Prairie Lake on the 9th day of December, 2014, and shall be in force in perpetuity, or until revoked by a future action of this Board or any succeeding Board thereof.
