## NOTICE OF SPECIAL TOWN MEETING OF THE ELECTORS OF THE TOWN OF PRAIRIE LAKE

**NOTICE IS HEREBY GIVEN** that on Tuesday, November 15, 2016, immediately following completion of the Public Hearing on the proposed 2017 Budget (at the same site), A **SPECIAL MEETING OF THE ELECTORS** called pursuant to §60.12(1)(c) of Wisconsin Statutes will be held for the following purposes:

1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under §66.0602 of Wis. Statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2016 by 29.2 percent which would be a dollar increase of \$109,947 over the allowable levy.
2. To establish compensation of the elected town officials for the term of office to begin in April, 2017, pursuant to §60.32 Wis. Statutes;
3. To approve the 2016 total town tax levy to be collected in 2017 pursuant to §60.10(1)(a) of Wis. Statutes.
