

Schedule of Penalties, Fees, Deposits, and Enforcement

Adopted by Town Board of the Town of Prairie Lake on 11/12/2013; Amended 5/8/2018

Before issuing a town citation, enforcement officials should contact the Barron County Clerk of Court to determine current court costs and procedures. Deposits shall be made in cash, money order, or certified check to the Barron County Clerk of Court who shall provide a receipt. The Town of Prairie Lake establishes the following schedule of deposits and designates the enforcement official(s) for use with citations issued under this ordinance.
